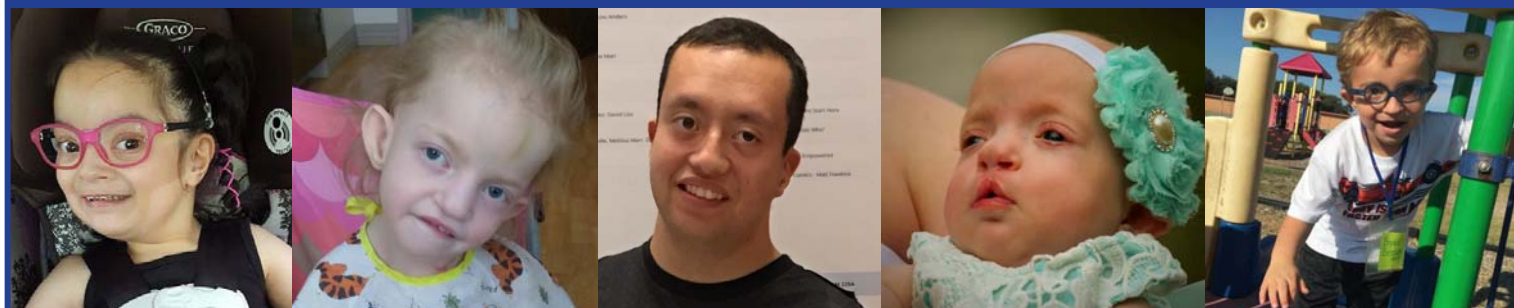

WOLF-HIRSCHHORN SYNDROME (WHS)

In basic terms, Wolf-Hirschhorn Syndrome (WHS), also known as 4p-Syndrome, is caused by distal deletion of the short arm of the 4th chromosome, with an occurrence of 1 in 50,000 live births. The syndrome is associated with cognitive and physical delays in children and adults. However, most individuals with this rare syndrome display loving and engaging personalities with life expectancies from newborn to adulthood.

Characteristics of WHS include:

- Slow Growth
- Developmental delays
- Cranial/facial distinctions
- Closure defects including cleft lip or palate
- Cardiac defects
- Low muscle tone
- Kidney defects
- Microcephaly
- Epilepsy
